



## Ambassador Season Pass Agreement

2009-2010

The Ambassador Pass program is a joint program offered through the Revelstoke Chamber of Commerce to its business members. This program is to help local businesses recruit and retain valuable employees through the winter season. The flexibility of the pass to transfer it means businesses can purchase a set number and hold them until the season when they can be assigned to staff and offer many creative ways such as an incentive or benefit for employment with that company. With the business owning the pass it may be revoked or transferred should an employee leave the company and will aid in finding a new staff member.

The Ambassador Pass cost is \$598 each plus GST and is only available until October 15, 2009.

### Terms & Conditions:

- Passes must be purchased by October 15<sup>th</sup>, 2009.



- The cost is \$598 plus 5% gst.
- The business must be a member of the Chamber of Commerce.
- Orders must be place through the Revelstoke Chamber of Commerce for approval.
- The pass will be assigned to one specific employee. An e-mail must be sent to Cat Malysh at [cmalysh@revelstokemountainresort.com](mailto:cmalysh@revelstokemountainresort.com) with the name of the person authorized to be given one of the pre-purchased passes.
- Passes remain the property of the business and may be revoked at the employer's request.
- Passes may only be transferred from one employee to another once per pass. \$50 transfer fee applies.
- It is the business's responsibility to ensure staff do not share the passes and they are used by the individual identified on the pass.
- Passes may not be sold for more than original purchase price.
- The pass holder is a representative of the city and resort. The pass will be revoked for any misconduct.
- Any breach of the terms and conditions will result in termination of the pass privileges.
- The employee must attend a scheduled informational seminar prior to the pass being issued. There will be at least one seminar prior to opening day and as required in season.
- The business agrees to participate in one of the RMR events during the winter season.
